Splits/Districts (EX-001)

This report lists district information by precinct and split.

Master Voter History List (EX-002)

Voter participation history for all elections recorded in the SCORE database for the current voters in Mesa County. The report joins voter information (party, address, etc.) with voting history and participation records. *Please note that the file contains a large amount of data.*

Registered Voter List (EX-003)

List contains basic voter information including voter ID, addresses, registration status, party affiliation, and precinct. This list does not include voter history.

Voter History List (EX-004)

List allows you to choose up to 5 specific elections in which to gather voter history. Fields include voter ID, name, address, registration status, precinct and chosen election history.

Voter History for Last 5 Elections (EX-005)

Contains voters and their election activity in the last 5 elections. This report is a variation on the EX-002 Master Voter History List, but is easier to digest and does not specifically require specialized database knowledge.

Registered Voter Report (VR-011)

List of registered voters in Mesa County including district information. This list is the standard generated list for voter data as needed for your business needs. Includes voter party, status and address information.

Please note that district information is subject to change over time. We recommend updating the VR-011 annually, or as districts change.

Voter Walking List

Contains list of registered voters and their addresses arranged by precinct groups. This data is according to address or even/odd addresses to facilitate walking on a single side of the street. Recommended for campaigns and canvassing. Please choose the districts, precincts, and party affiliations of interest before ordering.

Municipality and Special District Report Requests*

Municipalities and Special District Request only. This request is for a certified voter list to conduct a special election. Report is the VR-011 Registered Voter List of active and inactive voters. Fields include voters name, voter ID number, residential address, mailing address, ballot address, effective date, registration date, status, birth year, precinct, and party. This list includes confidential voters.

Reports are \$25.00 or \$0.01 per voter, whichever is greater [CRS 1-13.5-204(4) and 1-5-303(3)]

Agreement to protect voter confidentiality:

I affirm that I am requesting a complete list of active and inactive voters on behalf of our Special District/Municipality, with the express intention of using this list in order to conduct a special election.
